5. Annual Report – Adrienne White

We would encourage everyone to become a member of ASLIA, even if you aren't a qualified interpreter, because it shows you are supporting our goals. Go to our Facebook page to find out about upcoming events, or let us know you'd like to be on our email list. ASLIA supports Auslan-English and Deaf interpreters, including through discounted fees for professional development and the national conference. In the last year our goal has been to strengthen our relationships with Deaf organisations. We ran the Deaf Expo in October



2015 in collaboration with DCSSA - stalls, presentations, and Deaf Bhutanese community members joined us. It was also an opportunity for Deaf interpreters to volunteer. Australian Deaf Games in Jan 2016, and we ran a PD on Dec 5th 2015 and this PD helped us prepare with invited guests including Deaf Cricket Association and State representatives to help us understand the rules. June 2016 - Diploma of Interpreting students graduated and we held a *Welcome to the Profession Party* to celebrate, including the significance of Deaf interpreters getting their accreditation. August 2016 – we provided an Ethics presentation for the Deaf Community with Caroline Conlon. Held a Quiz Night in September 2015 to fundraise for COF (Creating Opportunities Fund) to support interpreters in the Australasia-Oceania region.

Upcoming PD:

Oct 14-16 National Auslan Conference in Melbourne - which will include celebrations for Deaf Australia (30th year) and ASLIA (25th year), with Australia's biggest Deaf Club on the Friday night ASLIA SA- November 2016 - Religious signs, and February 2017 - Della Goswell will run a workshop with us. Della is the Coordinator of the Macquarie University Post Graduate and Masters courses, is an interpreter and an interpreter educator of high regard nationally.

7. Treasurers report – Amy Blaylock

We always have our finances audited by Rosalie Kassulke. Please see the signed copy of the audited report. From running the Deaf Expo, we are the caretakers of seed funding for the next event and have some additional funds that will be shared with local Deaf organisations - in total this is just under \$5000.

The September 2015 Fundraiser quiz was to support interpreters in Samoa to attend ASLIA events, or to send interpreter trainers to the country e.g. Fiji,



and bring interpreters in from the region. Sending trainers to their country is the most efficient way as the professional development can be tailored to their needs.

We have an ASLIA SA PO Box, as having a postal address is a requirement of our Incorporation. We take out insurance which covers the committee and public liability for events.

Financial report for 2015-2016 has been audited by Rosalie Kassulke, signed by Rosalie and Amy, ASLIA SA Treasurer.

Amy Blaylock moved that the financial report be accepted, John Flynn seconded.

2016-2018 ASLIA SA report (6.3.)

ASLIA SA Committee

Since our 6th Annual General Meeting in September 2016, there have been a lot of changes at the state and national level. Our previous past president, Gerry Shearim worked with interpreting agencies to share the pertinent results of the members' survey so that work conditions and practices can be improved to support retention and professional development of interpreters in our field.

In December 2016, members endorsed a change in the national association structure at the ASLIA (national) Special General Meeting. Gerry joined the Interim ASLIA Committee in December, whose role was to continue the work of the previous Executive Committee until a new Constitution could be passed that incorporated the new structure. Before the end of the year we welcomed Claire Morrison to the ASLIA SA Committee.

Amy Blaylock joined the Interim ASLIA Committee as the 2nd SA rep and national Treasurer in Jan 2017. Shortly afterwards Gerry had to step down from both of her roles with ASLIA, and the SA Committee couldn't fill the role so continued without a President. By June 2017 a new Constitution had been presented to all ASLIA members around Australia and was adopted at a Special General Meeting, creating the ASLIA Board which is made up of each state association's President and a second representative, plus a representative from each state/territory without an association. We approached De Brown to support us in updating the ASLIA SA Constitution, as all state associations will need to, as she had also been an integral part of the development of the first Constitution in 2011.

Through the Board, each association has agreed to organise two livestreamed events for the National PD calendar. Based on feedback from the national member survey, SA will do 'Medical concepts in Auslan' as a collaboration with Caroline Conlon and Deaf Can Do, and 'Interpreting in tertiary settings' with Dr Jemina Napier when she is in Adelaide for the ANZCED Conference.

It is pleasing to note that ASLIA SA currently has its highest membership since reestablishment in 2011, with 30 members (8 Associate, 20 Ordinary, 1 Honorary Life, 1 Corporate), making up 7% of the ASLIA membership in Australia. Despite the challenges of being a small committee within a small local interpreting community, we are doing surprisingly well. Changes at the national level providing each state with representation on the Board, lower insurance premiums, administrative support and networks, have also provided us with a boost and renewed energy.

Partnerships

Partnerships are integral to our work, and here are a few examples of what has been happening in this space. In June 2017, ASLIA SA supported the AUSIT presentation on the INT project by providing interpreting, and in September with logistics and



equipment for Auslan Stage Left's 'Introduction to Theatre Interpreting' workshop. Amy met with Debbie

Kennewell from Deaf Can Do and we decided not to continue with the MOU regarding funding for PD support, but to work on PDs case by case and contribute flexibly e.g. opportunities for in-kind support, and each party providing support with planning.

We continue to enjoy the end of year interpreter celebrations that are supported by ASLIA SA, Deaf Can Do and Auslan Services, which give us all a chance to catch up with or meet new colleagues in a social setting and celebrate our achievements.

Professional development

ASLIA SA has been able to partner with other organisations and tap into national opportunities to share guest speakers and provide a professional development program that has complemented livestreamed events from around Australia.

- Oct 2016 the Auslan National Conference in Melbourne is attended by a number of ASLIA SA members. An excellent opportunity to understand interpreter and Deaf community perspectives, particularly around the impact of the National Disability Insurance scheme. Amy produced the program booklet
- Nov 2016 **Interpreting in religious settings** Nicole Clark and Chevoy Sweeney with the support of the Rose Park Uniting Church. 15 attendees.
- Feb 2017 Doug Bowen-Bailey **Interpreted Classrooms** PD coordinated nationally through ASLIA, and locally in partnership with AATD SA whom we split the profits with. Hosted by Klemzig Primary School. 22 participants.
- July 2017 Della Goswell's We need to talk.... PD working in teams, developing rapport, giving and receiving feedback. 11 attendees.
- Oct 2017 1st Street Leverage Book Club at Plant 4, Bowden. 6 attendees.
- Nov 2017 NEMP Emergency Interpreting PD partnership between TAFE SA, Deaf Can Do and ASLIA SA. Presenters Sarah Dempsey and Sarah Lewis. Over 30 attendees.
